## **Two Recreation Levels Are Available:**

**U6 Soccer** is perfect for young children in preschool and Kindergarten, beginning at age 3

**U8 Soccer** was created for First and Second graders.

## Fall Travel Soccer (U10/U15)

Designed for both boys and girls ages 8-14 years (third grade and up). Capital Area Soccer League (CASL) rules place children on teams by birth year, not their grade. We formulate teams based on the number of players registering and try to separate into boys and girls teams when possible. CASL rules state that girls may play on boys teams; however no boys may play on a girls team. Typically practice is 2 days a week at Tate Park; with the days and times being chosen by coaches. Games are usually Saturdays and/or Sundays; games are split between home games and games played in the Jackson/Lansing area. The season runs between late August and November. Uniform cost is not included in the registration fee, but will be required. Due to scheduling with other CASL teams, registration is due much earlier than the season start date.
